Report of the statutory auditor on the limited statutory examination to the General Assembly of the Friends of Oceana, Geneva

As statutory auditor, we have examined the financial statements (balance sheet, income statement and notes) of the Friends of Oceana for the year ended 31. Dezember 2019 .

These financial statements are the responsibility of the Executive Commitee. Our responsibility is to perform a limited statutory examination on these financial statements. We confirm that we meet the licensing and independence requirements as stipulated by Swiss law.

We conducted our examination in accordance with the "Swiss Standard on the Limited Statutory Examination". This standard requires that we plan and perform a limited statutory examination to identify material misstatements in the financial statements. A limited statutory examination consists primarily of inquiries of company personnel and analytical procedures as well as detailed tests of company documents as considered necessary in the circumstances. However, the testing of operational processes and the internal control system, as well as inquiries and further testing procedures to detect fraud or other legal violations, are not within the scope of this examination.

Based on our limited statutory examination, nothing has come to our attention that causes us to believe that the financial statements do not comply with Swiss law and the foundation's articles of incorporation.

NOTES TO THE FINANCIAL STATEMENTS

Business name, legal form and registered office

-The non-profit association is formed under the name Friends of Oceana and is governed by the most recent statutes (May 26, 2016) and by Art. 60 et seq. of the Swiss Civil Code. It is politically neutral and non-denominational.

-The Association is located in the Canton of Geneva c/o Walder Wyss AG Rue D'Italie 10 P.O. Box 1211 Geneva 3 Geneva, Switzerland

- -The purpose of the Association is to support the work of Oceana Inc., an international not for profit organization with a mission of protecting and restoring the world's oceans.
- -The financial statements for the period from 1 January 2019 to 31 December 2019 were subject to a limited statutory examination from Revision AG.

Principles applied in the annual accounts

- -According to the regulations under Swiss Law, Art. 957ff CO, Commercial Accounting and Financial Reporting.
- -According to the letter dated 28th October 2011 received from the Geneva tax authorities, the Association is tax exempted, at Cantonal and Communal level from 2011 and for the next 10 years, and permanently at Federal level.
