AMEND THE PUBLIC GFCM AUTHORISED VESSEL LIST TO STRENGTHEN COMPLIANCE AND TRANSPARENCY

Preventing public disclosure of information is a major impediment to achieving sustainable fisheries management and stringent fisheries enforcement. This problem is characterised by a lack of information on important elements of who is authorised to fish, where, when, how and what. Disclosure of information on the beneficial ownership of fishing vessels, and records of non-compliance of vessels or companies is also vitally important for improving accountability and assisting enforcement efforts. Lack of transparency on beneficial ownership or authorised vessel lists provides an excuse to flag and coastal states to evade their responsibility to enforce fisheries rules. Improving transparency and the accuracy and completeness of publicly accessible information is one of the most effective paths towards ending IUU fishing, and can expose and stop these activities.¹ Creating up-to date, public and comprehensive authorised vessel lists that include information on beneficial ownership will remove the current veil of secrecy and ambiguity of who can fish where, when, and what, as well as who benefits.

It is therefore essential to improve the public GFCM Authorised Vessel List, to make it complete, accurate, transparent and functional. This will also enable cross-checking of information and facilitate the detection of noncompliance cases.

Currently the GFCM has an authorized vessel list (GFCM/33/2009/6), a regional fleet register (GFCM/33/2009/5), as well as various other vessels lists for certain Fisheries Restricted Areas (FRAs) and Multiannual Plans. Only a few of these lists are public.

Following best practice in the International Commission for the Conservation of Atlantic Tunas (ICCAT), we recommend creating a single authorised vessel list that would include any vessel actively fishing for species managed by GFCM and subject to its management rules. The list should be updated on a regular basis, and any vessel not included in the authorised vessel list (and thus not authorised by the GFCM and the relevant flag state to operate in the GFCM management area) should be submitted to the Compliance Committee for possible inclusion in the IUU vessel list. Vessels which fail to fulfil registration requirements should not be added to the authorised vessel list and should thus be deemed unfit to operate in the Convention area. A regular update cycle of this list will further support the implementation of monitoring, control and surveillance (MCS) measures, including identifying IUU fishing activities.

To effectively stop IUU fishing and implement the Regional Plan of Action against IUU fishing we recommend improving the implementation of measures (data fields highlighted in orange) and amending Recommendation GFCM/33/2009/6 to include new data fields (highlighted in red).

In short, Recommendation GFCM/33/2009/6 should be amended to make the following data mandatory and public, in line with best practice in ICCAT:

-  Previous vessel name, previous flag state and previous owner
-  Owner's address, city, zip code and country
-  Operator's address, city, zip code and country
-  Main, secondary and tertiary geographical subarea (GSA)
-  If the vessel has an authorization to fish in a FRA. This is already required under Recommendation GFCM/33/2009/5 and should be included in the AVL. The following information should also be included:
 -  Information on the type of authorization including the target species or species groups; Number of fishing days; Fishing gear; Area and period authorized
 -  Type of fishing vessel
